3. As stated in Item III, Paragraph 3, (b), the color of the Modular Partition (50%-50%) – Light Blue (Upper part) and Royal Blue (lower part) must be strictly complied for uniformity of color scheme similar to the West Wing of the Office of the Government Corporate Counsel.
4. As stated in Item III, Paragraph 3, (e) (ii), page 43 of the Bidding Documents, the two (2) heavy duty duplex convenient outlets for each partition must be mounted at the base of the panel and with electrical line connection to the main power source.
5. Costs of dismantling and hauling of existing partitions are already included in the Approved Budget of the Contract.
