CONTRACT AGREEMENT

This Contract Agreement (“Agreement”) made and executed this 24th day of November 2020 at Quezon City, Metro Manila, by and between:

ANTECEDENTS

WHEREAS, the OGCC advertised the opportunity for the **PROCUREMENT OF TWENTY THREE (23) CARTS OF ORIGINAL TONER, HP CE285A (HP85A), BLACK** on 9 October 2020. The OGCC set the deadline for submission and opening of bids on 14 October 2020 at two o’clock in the afternoon. When the deadline for submission of quotations lapsed on 14 October 2020, four (4) bidders submitted their quotations:
