SUBJECT: BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROCUREMENT OF CD ASIA ONLINE ANNUAL SUBSCRIPTIONS

WHEREAS, the Office of the Government Corporate Counsel (OGCC), through its Bids and Awards Committee (BAC), intends to procure through Direct Contracting, "Annual CD Asia Online: Laws and Jurisprudence Subscriptions" pursuant to Section 50(c) of Republic Act (RA) No. 9184, for use of OGCC officials and employees.

It was also certified that there is no sub-dealer or agent for the electronic legal publications and that CD Asia is the sole and exclusive distributor thereof.

WHEREAS, the BAC found the quotation of CD Technologies Asia, Inc. to be acceptable and determined that CD Technologies Asia, Inc. is technically, legally and financially capable of delivering the goods and there are no suitable substitute in the market that can be obtained at more advantageous terms.

WHEREFORE, PREMISES CONSIDERED, THE BAC RESOLVES, AS IT IS HEREBY RESOLVED:

1. To recommend the award of the procurement through Direct Contracting of Annual CD Asia Online: Laws and Jurisprudence Subscriptions for a total contract price of Forty-Two Thousand Five Hundred Sixty Pesos (PhP42,560.00); and,
2. To recommend the issuance of Notice of Award by the Government Corporate Counsel, Head of the Procuring Entity, to the winning bidder.
