#### **V. INSPECTION**

All deliveries by suppliers shall be subject to inspection, and acceptance by OGCC Inspection Team and the end-user. All costs of the necessary laboratory tests undertaken by OGCC on the Goods shall be to the account of suppliers.

## **VI. LIQUIDATED DAMAGES**

A penalty of one-tenth of one percent (0.001) of the total value of the undelivered Goods shall be charged as liquidated damages for every day of delay of the delivery of the purchased Goods.

## **VII. PAYMENT**

Down payment shall not be allowed.

Payment shall be made *via* check within 30 cd following the date of receipt of the items, after due acceptance. Kindly coordinate with the OGCC Supply Office for the pick-up of the check.
