





CONTRACT AGREEMENT

MAY 05 2021

This Contract Agreement ("Agreement") made and executed this 5th day of May 2021 at Quezon City, Metro Manila, by and between:

OFFICE OF THE GOVERNMENT CORPORATE COUNSEL (OGCC), a government agency with address at 3rd Floor, MWSS Building, Katipunan Avenue, Diliman, Quezon City, represented here by its Government Corporate Counsel, **ATTY. ELPIDIO J. VEGA**;

and

BUSINESS WORLD PUBLISHING CORPORATION (BUSINESS WORLD), a corporation duly organized and existing under Philippine laws, with address at 95 Balete Drive Ext. New Manila, Quezon City, Metro Manila, Philippines, represented here by its Territory Manager, **JUAN T. SANTOS**.

ANTECEDENTS

WHEREAS, the Office of the Government Corporate Counsel (OGCC), through its Bids and Awards Committee (BAC), intends to procure through Direct Contracting the Procurement of Business World Newspaper (Project) with an Approved Budget for the Contract of Five Thousand Pesos (PhP5,000.00) pursuant to Section 50(a) of Republic Act (RA) No. 9184, for use of OGCC officials and employees.

WHEREAS, on 22 February 2021, the OGCC, through its BAC, sent the Request for Quotation (RFQ) to Business World Publishing Corporation (Business World). On 23 February 2021, the OGCC, through its BAC, received Business World's quotation.

WHEREAS, the quotation of Business World is acceptable to the BAC and determined that Business World is technically, legally and financially capable of delivering the goods at the most advantageous price and contract for the Government. Hence, The OGCC BAC issued BAC Resolution No. 07, series of 2021 declaring BUSINESS WORLD the winning bidder and recommended the Issuance of a Notice of Award (NOA) in favor of BUSINESS WORLD.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, *viz*:
 - (a) BUSINESS WORLD's RFQ;
 - (b) Technical Specifications;
 - (c) Notice to Proceed;
 - (d) 2021 Mayor's/Business Permit;
 - (e) PhilGEPS Registration Number; and
 - (f) Notice of Award.
3. In consideration of the payments to be made by the OGCC to BUSINESS WORLD as hereinafter mentioned, BUSINESS WORLD hereby covenants with the OGCC to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract, in accordance with the Terms of Reference and Terms of Conditions of the Contract.

OGCC hereby covenants to pay the BUSINESS WORLD in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
