**AMENDMENT TO THE CONTRACT OF ENGAGEMENT OF
COVER AND PAGES CORPORATION UNDER CONTRACT ID CBOA-
111220 FOR THE PRINTING OF THE OGCC COMMEMMORATIVE BOOK**

This Agreement made and executed this **FEB 15 2022** day of February 2022 at Quezon City, Metro Manila, by and between:

OFFICE OF THE GOVERNMENT CORPORATE COUNSEL, a government agency with address at 3rd Floor, MWSS Building, Katipunan Avenue, Diliman, Quezon City, herein represented by **Government Corporate Counsel ELPIDIO J. VEGA**, Head of the Procuring Entity, and hereinafter referred to as "**OGCC**";

and

COVER AND PAGES CORPORATION, duly organized and existing under Philippine laws, with address at 2763 Silang St., Sta. Ana, Manila, herein represented by **MARIFE B. LOYOLA**, Owner and hereinafter referred to as "**Cover and Pages**"

ANTECEDENTS

WHEREAS, on 12 November 2020, the OGCC awarded the contract for the printing of the OGCC commemorative book to Cover and Pages Corporation pursuant to Section 53.6 of the 2016 RIRR of RA No. 9184;

WHEREAS, Item 2 of the contract states that any Contract Amendment shall be deemed to form part of the Contract;

WHEREAS, under Clause III Item 1, it is recognized that any changes, if requested by the OGCC may result in additional charges subject to the agreement of both parties, and in Item 3 that the commemorative book shall be subject to inspection and acceptance prior to payment;

WHEREAS, on 12 December 2021, the OGCC requested for a change or amendment in the specifications;

WHEREAS, on 22 December 2021, submitted a revised quotation in response to the change in specification directed by the OGCC;

WHEREAS, on 19 January 2022, the OGCC Commemorative Book Committee submitted to the BAC its recommendation to amend the Contract;

WHEREAS, on 8 February 2022, the BAC favorably endorsed the approval of the request of the OGCC Commemorative Book Committee for Contract amendment.

NOW THEREFORE, in consideration of the above stipulations, the parties agreed on the following:

2. **PROJECT COST.** In consideration of the printing services to be provided by **Cover and Pages Corporation**, OGCC hereby agrees to pay **Cover and Pages Corporation** the total Contract Price of **FIVE HUNDRED FIFTY-EIGHT THOUSAND PESOS (PhP558,000.00)**, inclusive of VAT and all other taxes, under the provisions of this contract.

3. OTHER TERMS AND CONDITIONS.

- a. Any violation by either party of the terms and conditions herein set forth shall be a basis for the termination of this contract. In such event, the aggrieved party will make a formal notice to the other party of the term and condition violation. However, despite the right to terminate, the parties shall endeavor to amicably or extra-judicially settle the matter.
- b. The provision of the original contract not contrary hereto shall continue to govern the parties.


