

### CONTRACT AGREEMENT

THIS AGREEMENT made the DEC 29 2022 day of December 2022 between the **OFFICE OF THE GOVERNMENT CORPORATE COUNSEL** of the Philippines (hereinafter called "the Entity") of the one part and **JONECO TECH MARKETING CORP.** of Mandaluyong City (hereinafter called "the Supplier") of the other part;


