CONTRACT

THIS CONTRACT made this 4th day of October 2023 between the **Office of the Government Corporate Counsel (OGCC)**, represented by the Head of the Procuring Entity, Government Corporate Counsel **ROGELIO V. QUEVEDO** and **K Servico Trade**, **Inc. (K Servico)**, represented by **MS. GERLY B. ELORDE**, duly authorized for this purpose as evidenced by the Secretary's Certificate dated 2 February 2023 executed by Mr. Gelacio A. Mamaril, K Servico's Corporate Secretary (Annex "A");

WHEREAS, OGCC requested quotations for the **Supply and Delivery of Three** (3) **Motorcycle Units** (125cc to 200cc) and has accepted the quotation by K Servico for the performance of such service in the sum of **Two Hundred Eighty-Five Thousand Pesos** (PhP285,000.00) (hereinafter called "the Contract Price").

WHEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference (ToR) and the Request for Quotation (RfQ) referred to.
- 2. The following documents shall be deemed to form and be read and construed as integral part of this Contract, *viz*.:
 - i. RfQ and ToR;
 - ii. K Servico's quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Notice of Award of Contract, and K Servico's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the OGCC. K Servico agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the Contract Price, K Servico agrees to perform the supply and delivery of the three (3) motorcycle units in accordance with its quotation and the ToR.



4. The OGCC agrees to pay the above-mentioned sum in accordance with the terms of the RfQ.

IN WITNESS whereof, the parties hereto have caused this Contract to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
