CONTRACT

THIS CONTRACT made this 20th day of November 2023 between the Office of the Government Corporate Counsel (OGCC), represented by the Head of the Procuring Entity, Government Corporate Counsel Rogelio V. Quevedo and New A.G. Stylist Furniture (New A.G.), represented by MR. JOSE GO, duly authorized for this purpose;

WHEREAS, OGCC requested quotations for the Supply and Delivery of Furniture and Fixtures for the Enhancement of the Satellite Conference Room located at the MWSS Engineering Building (Lot 1 and Lot 2), and has accepted the quotation for Lot 1 by New A.G. for the performance of such service in the sum of Eighty-Six Thousand Four Hundred Pesos (PhP86,400.00) (hereinafter called "the Contract Price").

WHEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

- 1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference (ToR) and the Request for Quotation (RfQ) referred to.
- 2. The following documents shall be deemed to form and be read and construed as integral part of this Contract, *viz*.:
 - i. RfQ and ToR;
 - ii. New A.G.'s quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Notice of Award of Contract, and New A.G.'s conforme thereto; and
 - ii. Other contract documents that may be required by existing laws and/or the OGCC. New A.G. agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration of the Contract Price, New A.G. agrees to perform the supply and delivery of Lot 1 of the Furniture and Fixtures for the Enhancement of the Satellite Conference Room located at the MWSS Engineering Building in accordance with its quotation and the ToR.
- 4. The OGCC agrees to pay the above-mentioned sum in accordance with the terms of the RfQ.
