



CONTRACT

THIS CONTRACT made this 26th day of January 2024 between the **Office of the Government Corporate Counsel (OGCC)**, represented by the Head of the Procuring Entity, **Government Corporate Counsel Rogelio V. Quevedo** and **CD Technologies Asia, Inc.**, represented by **Mr. Rex J. Cabutihan**, duly authorized for this purpose;

WHEREAS, OGCC requested quotations for the **"One (1) Year Hosting Service for OGCC Legal Information Archive"** and has accepted the quotation of **CD Technologies Asia, Inc.** for the performance of such service in the sum of **One Hundred Fifty-Seven Thousand Two Hundred Forty-Eight Pesos (PhP157,248.00)** (hereinafter called **"the Contract Price"**).

WHEREFORE, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference (TOR) and the Request for Quotation (RFQ) referred to.
2. The following documents shall be deemed to form and be read and construed as an integral part of this Contract, *viz.*:
 - i. RFQ and TOR;
 - ii. CD Technologies Asia, Inc.'s quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Notice of Award of Contract and CD Technologies Asia, Inc.'s conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the OGCC. CD Technologies Asia, Inc. agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the Contract Price, CD Technologies Asia, Inc. agrees to perform the **"One (1) Year Hosting Service for OGCC Legal Information Archive"** in accordance with its quotation and the TOR.
4. The OGCC agrees to pay the above-mentioned sum in accordance with the terms of the RFQ.




