

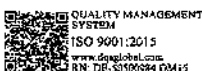

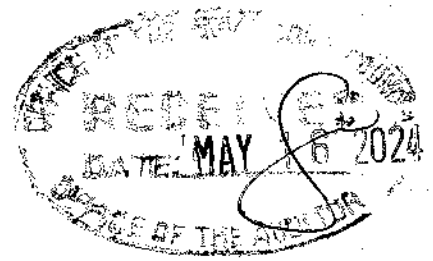

## CONTRACT

This **CONTRACT** made this 3rd day of May 2024 between the **Office of the Government Corporate Counsel (OGCC)**, represented by the Head of the Procuring Entity, Government Corporate Counsel Solomon M. Hermosura and **Onstrike Library Solutions**, represented by **MR. JERWYN G. FERNANDEZ**, duly authorized for this purpose;

**WHEREAS**, OGCC requested quotations for the **Supply and Delivery of One (1) Lot of OGCC Library Modernization System**, and has accepted the quotation of **Onstrike Library Solutions** for the delivery of such goods in the sum of **Seven Hundred Forty Five Thousand Pesos (PhP745,000.00)** (hereinafter called "the Contract Price").

**WHEREFORE**, THE PARTIES HEREBY AGREE AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Terms of Reference (ToR) and the Request for Quotation (RfQ) referred to.
2. The following documents shall be deemed to form and be read and construed as integral part of this Contract, *viz.*:
  - i. RfQ and ToR;
  - ii. Onstrike Library Solutions's quotation, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Notice of Award of Contract, and Onstrike Library Solutions's conforme thereto; and
  - ii. Other contract documents that may be required by existing laws and/or the OGCC. Onstrike Library Solutions agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the Contract Price, Onstrike Library Solutions agrees to perform the supply and delivery of One (1) Lot of OGCC Library Modernization System in accordance with its quotation and the ToR.
4. The OGCC agrees to pay the above-mentioned sum in accordance with the terms of the RfQ.



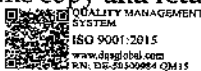
