CONTRACT

THIS CONTRACT made this 21st day of June 2024 between the **Office of the Government Corporate Counsel (OGCC)**, represented by the Head of the Procuring Entity, **Government Corporate Counsel Solomon M. Hermosura** and **Thinc Office Corp.**, represented by **Mr. Joseph Dexter M. Feliciano**, duly authorized for this purpose;

WHEREAS, OGCC requested quotations for the **"One (1) Year Subscription to Sixteen (16) Accounts of Online Legal Reference"** and has accepted the Quotation of **Thinc Office Corp.** for the delivery of such service in the sum of **Seven Hundred Fifty Thousand Pesos (PhP750,000.00)** (hereinafter called **"the Contract Price"**).

 - iii. Notice of Award of Contract and Thinc Office Corp.'s conform thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the OGCC. Thinc Office Corp. agrees that additional contract documents or information prescribed by the GPPE that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the Contract Price, Thinc Office Corp. agrees to deliver **"One (1) Year Subscription to Sixteen (16) Accounts of Online Legal Reference"** in accordance with its quotation and the TOR.
4. The OGCC agrees to pay the above-mentioned sum in accordance with the terms of the RFQ.




